The Government of the People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) toward the cost of **Urban Primary Health Care Services Delivery Project-Additional Financing (UPHCSDP-AF)**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to all Bidders from eligible source countries of the ADB
2. The Project, on behalf of the Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives ("the Purchaser") invites sealed bids from eligible Bidders for the Procurement of Medical Equipment for CRHCC and PHCCs of PAs under UPHCSDP-AF.
3. National Competitive Bidding (NCB) will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
  - **Contractual Experience:** Successful completion as main supplier within the last Three (3) years, of at least one contract valued for Lot-1 is BDT 1,50,00,000.00 (One Crore Fifty Lakh) and for Lot-2 is BDT 50,00,000.00 (Fifty Lakh) with nature, and complexity similar to the following:-  
  
**Lot-1:** (1) ECG Machine, (2) Baby Radiant Warmer, (3) General Anesthesia (GA) Machine, (4) Hospital bed, (5) Instant Power Supply (IPS) 2KV,(6) Equipment for medical waste management plant for CRHCCs and (7) Equipment for medical waste management plant for PHCCs of PAs.  
  
**Lot-2:** (1) Air Conditioner, (2) Generator
  - **Average Annual Turnover:** Minimum average annual turnover of BDT 95,00,000.00 (Ninety Five Lakh) for Lot-1 and BDT 31,00,000 (Thirty One Lakh) for Lot-2 calculated as total payments received by the Bidder for contracts completed or under execution over the last Three (3) years.
